This deed of Trust executed this 12th day of December 1997 at Kuttalam by R. PANDIAN, 12-A/3 Pudhu Nagar, Kuttalam, Mayiladuthurai Taluk, Nagai District (hereinafter called the Author of the Trust).

Whereas, the Author of the Trust has all along been interested to do something to the cause of Education.

Whereas, the Author of the Trust, to give practical action to his long standing aim to serve the Society as a whole, is now desirous of forming an Educational Trust with the objects which are more specifically detailed hereto.

Whereas, the Author of the Trust has decided to name the Trust as RAJ VIDYALAYA EDUCATIONAL TRUST and this day set apart a sum of Rs.1,000/- (Rupees one thousand only) towards the nucleus of the Trust and handed over the said sum to the trustees, referred to hereinbelow, with a humble request that the Trust be maintained towards fulfilling his aim as per the Terms and conditions set out hereinbelow and utilise the Trust fund including all accumulations and accretions thereto and the income there from, for the intents and purposes hereinbelow mentioned:

1. The name of the Trust shall be, as already given, as said above, and its office for the present shall be located at the premises No.23, UTHIRA NORTH CAR STREET, KUTTALAM, Mayiladuthurai Taluk, Nagai District.

2. The object of the Trust shall be as under:-

- i. To establish, maintain, assist, finance, help or promote Educational Institutions including Technical and Medical Education.
- ii. To establish, promote, assist, finance, maintain, support or help in the setting up and/or maintaining and or running schools, Engineering and Medical colleges, Polytechnics, Industrial Training Schools and such other institutions for advancement of education and of knowledge in arts, science, literature, humanities and all other useful subjects in all their manifestations.
- iii. To establish, promote, assist, finance, support or help in the construction of hostels, libraries, reading rooms, gymnasium, science and technical laboratories, community hall, prayer hall and class rooms for the benefit of students.
- iv. To meet Travelling, Boarding and lodging expenses for students going abroad for higher commercial and technical education.
- v. To grant scholarships, donations and other incentives to benefit students and others in educational pursuit.
- vi. To incur expenditure for the maintenance of schools, colleges and such other educational institutions inclusive of payment by way of salary, honorarium towards teaching or non-teaching staff, maintenance of School buildings, Play grounds, laboratories of such institutions as and when necessity arises.
- vii. To incur expenditure to improve music, dance, drama, fine arts and other popular arts and to develop cultural and literary activities and to create sense of secularism, patriotism, duty, dignity and discipline among the students community.
- viii. To incur expenditure at the time when the educational institutions celebrate important functions and occasions from time to time.
- ix. To incur expenditure to encourage sports activities amongst the students.
- x. To incur expenditure towards purchase of Furniture and other laboratory equipments needed for the educational institutions, including electrical items that are needed for time to time.
- xi. To incur expenditure for the purchase of vehicles like Buses, Vans, Cars and ~~the~~ maintenance of the same for the purpose of Educational institutions.
- xii. To incur expenditure towards developing computer education for the students community at large and to start any other technical education.

- xiii. To incur any other expenditure which would be in the interest of the educational institutions as a whole and towards the welfare of the students community at large.
- xiv. Power is however given to the trustees to give preference to THIRU. R. PANDIAN, the Author of the Trust in the implementation of the objects of the Trust which school out and out impart the objects of the Trust which school out and out impart the education to the students of all communities in and around Kuttalam Town.
- 3) For the removal of doubts, it is hereby declared that this Trust, its objects and its implementations shall not be for benefit of any particular caste or religious community as such.
- 4) The Trust is irrevocable.
- 5) The Author of the Trust hereby declares that a sum of Rs.1,000/- (Rupees one thousand only) has been dedicated by him as the Corpus of the Trust and the Trustees, will stand possessed of the above sum of Rs.1,000/- (Rupees one thousand only) upon Trust for carrying out the abovementioned objects.
- 6) (a) The Following shall be the First Trustees of the Trust and shall constitute the Board of Trustees of the Trust:
1. Thiru. R. Pandian, son of Thiru. R. Rajamnickan, 12-A/3 Pudhu Nagar, Kuttalam.
 2. Thiru. R. Selvan, son of Thiru. R. Rajamnickan, Sengamettu Street, Mayiladuthurai.
 3. Thiru. R. Rajamnickan, West Street, Palayagudalur.
 4. Mnt. S. Sumathi, W/o. Thiru. R. Selvan, Sengamettu Street, Mayiladuthurai.
 5. Mnt. P. Rajeswari, W/o. Thiru. R. Pandian, 12-A/3 Pudhu Nagar, Kuttalam.
 6. Thiru. S. Arunkumar, S/o. Thiru. R. Selvan, Sengamettu Street, Mayiladuthurai.

Of the above Six Trustees the all Six Trustees shall be Life time Trustees and they shall hold office as Trustees during their life time unless they vacate the Office earlier for any reason whatsoever. In the event of there being a vacancy in the office of such Trustees, it shall be filled up by the mutual consent amongst the other Trustees and such co-opted trustee shall hold the office for a period of Three years from the date of his appointment.

The remaining above Trustees shall hold Office for a period of Three years from the date of this deed. And such Trustees are eligible for re-appointment if the Board of Trustees so decide. In the event of there being a vacancy in the office of such Trustee, it shall be filled up by the mutual consent amongst the other Trustees and such co-opted Trustee shall hold the office for a period of Three years from the date of his appointment.

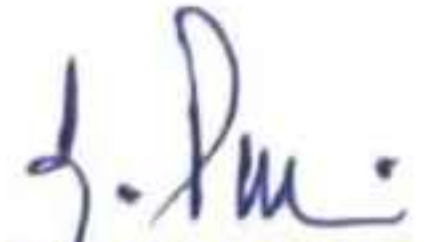

The vacancy arising on account of the Ex. Officio Trustee relinquishing / completing their respective posts, shall be filled in this Trust by their respective successors in Office.

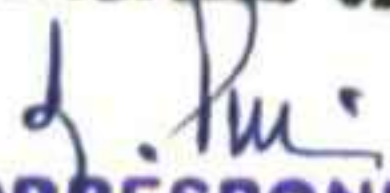
- (b) The Board of Trustees shall consists of not less than two and not more than Twelve.
- (c) Thiru. R. Pandian shall be the Managing Trustee of this Trust and shall hold such office for a period of Three years from the date of this document and in the event of there being a vacancy in the office of such Managing Trustee, it shall be filled up by the mutual consent amongst the Trustees. The period of Office of a Managing Trustee shall be for a period of Three years from the date of his appointment to such office.
- (d) The Board of Trustees shall have power at their discretion to co-opt persons whom they deem fit and proper so that the total number of trustees shall not exceed twelve at any point of time. Such co-opted Trustees shall hold Office for a period of three years from the date of thier respective appointments.
- (e) The Board of Trustees shall have the power to remove any Trustee if his acts are detrimental to and inconsistent with the objects of the Trust or if he is disqualified to be a Trustee under the Indian Trust Act and the Vacancy so created shall be filled up in the manner discussed already in above.
- 7) All the decisions of the Board of Trustees shall be according to the decisions of the majority of the Board of Trustees and the minimum for quorum for the Board Meeting shall be Three. The Managing Trustee shall have the right of Second Vote in case of equality of votes in the meeting. A circular resolution issued by the Managing Trustee on any subject which he deem urgent and signed by a majority of the Trustees of the Board shall in all respects be as valid and binding as a resolution passed at a meeting of the Board of Trustees duly convened and constituted and such resolution shall not be deemed invalid by reason of want of notice or any other cause whatsoever.
- 8) The Meeting of the Board of Trustees shall be convened by the Managing Trustee by giving atleast Three days notice before the meeting of the Board. In case of any emergency meeting clear one days notice shall be given. In special circumstances Two third of the Trustees may convene the Board Meeting.
- 9) The Managing Trustee shall preside over the meeting of the Board of Trustees and if he is not present or decline to take the chair at any meeting, the members present shall elect one of them to be a chairman of the meetings.
- 10) A Minute Book shall be maintained to record the proceedings of every meeting of the Board of Trustees duly signed by the chairman of that meeting.
- 11) The Managing Trustees of the Trust shall have overall management of the activities of the Trust including employing servants and others and otherwise deal with the monies of the Trust towards proper fulfillment of the objects of the Trust.

- 12) The Board of Trustees are empowered to obtain donations and other amounts from the general public as may be found necessary from time to time for the proper fulfillment of the objects of the Trust.
- 13) The Board of Trustees are empowered to borrow monies from banks or others with or without security.
- 14) The Board of Trustees shall have power to acquire, hold enjoy and deal with the disposal of properties of every description for and on behalf of the Trust.
- 15) The funds of the Trust may be invested in Bank Deposits, Government Bonds or such other appropriate securities as the Board of Trustees may decide from time to time in accordance with the provision of Sec. 13(1(d) read with Sec. 11(5) of Income Tax Act.
- 16) The Managing Trustee shall, along with another member of the Board of Trustees, operate Bank accounts on behalf of the Trust.
- 17) The Board of Trustees may empower the Managing Trustee to represent or act for the Trust in matters concerning the properties, funds, investments, borrowings and making or cancellation of any instruments for any of these purposes.
- 18) The Board of Trustees shall maintain or cause to be maintained proper and regular books of account and shall make up accounts every year on 31st March and the accounts and balance sheet shall be audited by a qualified Chartered Accountant.
- 19) All acts and proceedings of the Trust shall be taken and conducted in the name of Trust.
- 20) No part of income or assets of the Trust shall be transferred or applied at any time for any purposes otherwise than for the fulfillment of the objects of the Trust, subject to making of investments specifically mentioned hereinabove.
- 21) The Board of Trustees are empowered to make rules for the proper governance or administration of the Trust, but such rules shall not go against the objects of the Trust.
- 22) The income and funds of the Trust shall be solely towards the objects of the Trust and no portion of it shall be utilised for payment to Trustees by way of profit, salary, interest, dividends etc.
- 23) Any amendment of Trust Deed shall be carried out only with the approval of Commissioner of Income Tax.
- 24) The Trust shall not carry on any activities outside India.
- 25) The Trust shall not carry on any activity with the intention of earning profit.

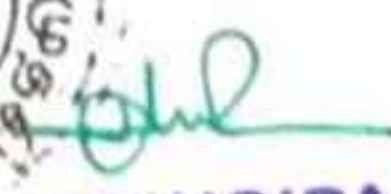

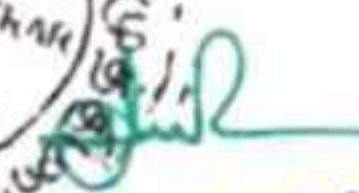

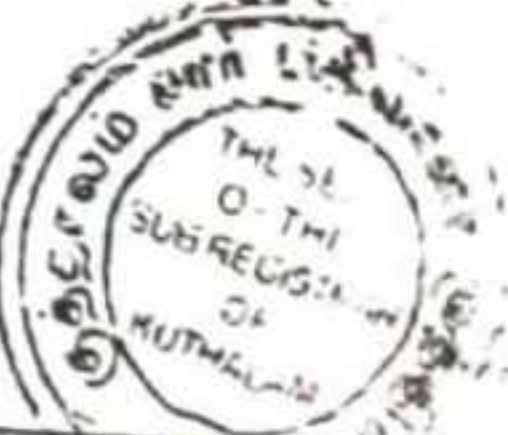
